



ROSS TOWNSHIP RESOLUTION NUMBER 2018-044

RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION, AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

WHEREAS, the Board of Trustees of Ross Township, Butler County, Ohio, in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2019; and

WHEREAS, the Budget Commission of Butler County, Ohio has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board and what part thereof is without, and what part within, the ten mill tax limitation.

BE IT RESOLVED by the Trustees of Ross Township, Butler County, Ohio, pursuant to Sections 5705.34 and 5705.35 of the Revised Code, as follows:

SECTION 1-A:

That the amounts and rates as determined by the Budget Commission in its certification, be and are the same and hereby accepted; and

SECTION 1-B:

That there be and is hereby levied on the tax duplicate of said Township the rate of each tax necessary to be levied within and without the ten mill limitation per the attached Schedule A and Schedule B found herein as Exhibit "A"; and

SECTION 1-C:

That the Fiscal Officer of this Board be and hereby is directed to certify a copy of this Resolution to the County Auditor of Butler County, Ohio.

SECTION 3:




INTRODUCTION AND VOTE RECORD:




