



ROSS TOWNSHIP RESOLUTION NUMBER 2018-053

RESOLUTION AUTHORIZING APPLICATION FOR A GRANT FROM THE BUTLER COUNTY DEPARTMENT OF DEVELOPMENT FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS TO ASSIST WITH THE ESSENTIAL COST FOR THE S.R. 128/SCHOOL/LAYHIGH ROAD SIDEWALK CONSTRUCTION PROJECT AND AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO EXECUTE ANY REQUIRED DOCUMENTS IN CONNECTION WITH THE GRANT APPLICATION

WHEREAS, the Ross Township Board of Trustees finds it necessary and desirable to construct sidewalk along a certain portion of School & Hamilton Cleves Roads to prepare and submit an application for a grant to fund a portion of the Ross Township S.R. 128/School/Layhigh Road Sidewalk Construction Project; and

WHEREAS, the Board desires to apply for a grant from the Butler County Department of Development for Community Development Block Grant funds to assist with the essential cost during the undertaking said project; and

WHEREAS, the Board desires that the Township Administrator apply to the Butler County Department of Development; for said Community Development Block Grant funds by submitting and executing any documents required in connection with the grant application.

BE IT RESOLVED, by the Trustees of Ross Township, Butler County, Ohio, as follows:

SECTION 1-A:

That the Board of Trustees make application for a grant of \$248,580.00 for Community Development Block Grant funds through the Butler County Department of Community Development to assist with a portion of the essential cost during the undertaking the Ross Township S.R. 128 Sidewalk Construction Project.

SECTION 1-B:

That the project grant application reflects that \$27,620.00 of the \$276,200.00 total project cost is hereby committed from the General Fund of Ross Township.

SECTION 1-C:

That Robert W. Bass, Township Administrator, be and hereby is authorized to submit and execute any documents required in connection with the grant application authorized herein.

SECTION 2:

This resolution shall take effect on November 1, 2018 following the filing of this resolution with the Ross Township Fiscal Officer.

SECTION 3:



INTRODUCTION AND VOTE RECORD:






